4. This is issued subject to the condition that the school will follow the directions of the department issued from time to time.
5. That no request for sponsorship of land at any stage will be considered.
6. This essentiality certificate is subject to the out come of notification to be issued by the Ministry of Urban Development, Govt. of India, with regard to non confirming areas.
